1 **Ymweliad/ Vist:-** Roedd Ms Lesley Parker, The Solutions Factory, yn bresennol yn y cyfarfod a thrafodwyd pwyntiau ynghylch datblygu gwefan. 8 **Review of Insurance Cover** – Details of the cover received from Zurich Municipal had been circulated and was unanimously approved to continue with the policy. A cheque was passed for payment in the sum of £1,225.77.

9 **Casual Vacancy:-** An interest in the vacant seat has been shown. A formal letter to be requested.

10 **Review of Standing Orders:-** Cllr Keith Evans proposed that the Standing Orders are accepted as they currently are, this was seconded by Cllr Andrew Howell and carried. It was again stated that the Standing Orders should be read on a regular basis and reviewed yearly.

Consultation – It was decided to hold a Special Meeting on Tuesday 19.3.2013 and all were requested to go through the document prior to this to enable us to respond. The **Street Cleaner** at Llandysul has resigned. Applicants for the post have been shortlisted and interviews are to take place as soon as possible. It was decided to write to Ceredigion to ensure that the litter picker monitors the recycling banks on a regular basis. Fly tipping at the recycling banks also to be reported to the environmental department.

Parking Restrictions at Llandysul –
