9. **Balchder Pentrefi** Draft wording for the park boards were received and it was decided to carry on with the suggested wordings from Cymdeithas Hanes Llandysul. All other works were well underway and all Councillors were informed that the works had to be completed and invoices received by the council no later than 31 October 2013.
10. **Young People in the Community** – No further progress has been made.
11. **Development of Llandysul Flowers** Cllr Andrew Howell informed the committee that Farm Yard Nursery's would be replanting on 14 June 2013. The development of the flowers would be put back on the agenda early next year.
12. **Dog Excreta** It was resolved to contact the park trustees and the Sports Committee once more regarding the increasing problem of dog excreta. Cllr Aled Jones would relay the problem to the Sports Committee and the clerk should contact the trustees. We continue to await response from Ceredigion as to what help and support is available.
13. **Badges** Cllr Terry Griffiths reminded the Cllrs the importance of wearing badges to all public events. All members that didn't have one could purchase a badge for £5.00 with the proceeds going to Charity. It was resolved to check with the Community Councils insurance that the Chairman's chain was insured for the correct amount.
14. **Disquiet in Prengwyn** Cllr Tom Coucher informed the Committee of the ongoing problems in Prengwyn with regards to the Public House and complaints of increased noise in the village. A copy of a Community Opinion Poll was shown to the members and it showed that all but one house in the
