**Minutes of Monthly Meeting of Cyngor Cymuned Llandysul Community Council held at Canolfan Ieuenctid Tysul Youth Centre, Llandysul, on 14 March 2011**

1 **Prosiect Chwarae Plant RAY Ceredigion** – Cafwyd cyflwyniad gan Cathryn Morgan am Brosiect Chwarae Plant y Loteri Fawr, sy'n cynnig sesiynau chwarae mynediad agored yn rhad ac am ddim mewn cymunedau ar draws y sir, yn ogystal â chyngor ynghylch tirlunio safleoedd chwarae cymunedol. Diolchodd y Cadeirydd i Ms Morgan am fynychu/ **RAY Ceredigion Child's Play Project** - Cathryn Morgan gave a presentation on the Big Lottery Child's Play Project providing free of charge open access play sessions in the communities across the county and advice on landscaping community play areas. Chair thanked Ms Morgan for attending.

**6 Rhoddion:-**

a) Canolfan Ceufad Llandysul Paddlers

Canoe Centre – Ni chafwyd unrhyw wybodaeth bellach a bydd yr eitem hon yn aros ar yr agenda ar gyfer y cyfarfod nesaf.

b) Urdd y Benywod Pantydefaid – (a145) – Mae'r Ramp i'r Anabl ar gyfer y cyhoedd wedi cael ei osod erbyn hyn a gofynnwyd am y grant a gymeradwywyd yn flaenorol, ond am y swim is o £1056 (yn lle £1081), gan bod y cyflenwr wedi rhoi gostyngiad, a derbyniwyd y dylid anfon sieci i dalu am y gwaith.

**6 Donations:-**

Canoe Centre – No further information was received and will remain on the agenda for next month.

b) Pantydefaid Womens League – (s145) – Disabled Ramp for use by the public is now in position and a request for the grant previously approved was received at a lower price of £1056 (instead of £1081) as the supplier had given a discount and cheque was passed in payment.

- d) **Ambiwlans Awyr Cymru** – (a137) – Penderfynwyd y dylai'r Cyngor, yn unol â'i bwerau dan Adran 137 Deddf Llywodraeth Leol 1972, wario'r symiau canlynol, y maent er budd yr ardal neu ei thrigolion ym marn Cyngor Cymuned Llandysul, ac y bydd yn cynnig budd iddynt mewn ffordd sy'n gymesur gyda'r gwariant – Cynigiodd Cyng Keith Evans y dylid rhoi £300, eiliwyd hyn gan Gyng Wyn Evans ac fe'i derbyniwyd.
- e) **Eisteddfod Ryngwladol Llangollen** – (a145) – Cynigiodd Cyng Keith Evans y dylid rhoi £50, eiliwyd hyn gan Gyng Wyn Evans ac fe'i derbyniwyd.
- f) **Cymorth i Fenywod Aberteifi** – (a142) – Cynigiodd Cyng Keith Evans y dylid rhoi £50, eiliwyd hyn gan Gyng Wyn Evans ac fe'i derbyniwyd
- g) **Shelter Cymru** – (a142) – Cynigiodd Cyng Keith Evans y dylid rhoi £50, eiliwyd hyn gan Gyng Wyn Evans ac fe'i derbyniwyd.
- h) **Llandysul a Phontweli Ymlaen** – Cafwyd cadarnhad y bu'r Digwyddiad Garddio yn ddigwyddiad llwyddiannus a bod masnachwyr Llandysul wedi cael budd o'r digwyddiad. Yn flaenorol, cymeradwywyd grant o £1,000 ar gyfer y digwyddiad a derbyniwyd y dylid ei dalu. Yn ogystal, gofynnwyd i ni ystyried wneud cyfraniad at ddigwyddiad 2012 oherwydd y bydd angen iddynt benderfynu cyn bo hir a fydd y digwyddiad yn cael ei gynnal y flwyddyn nesaf, a bydd hyn yn cael ei roi ar yr Agenda ar gyfer y cyfarfod nesaf.
- 7 **Banc Lloyds Llandysul** – Cafwyd trafodaeth ynghylch yffaith bod Cangen Llandysul wedi cau, a bydd hyn yn cael ei roi ar yr Agenda ar gyfer y cyfarfod nesaf er mwyn ei drafod. Bydd Cyng Peter Davies yn gwneud ymholiadau gyda'r banciau yn Llandysul er mwyn sicrhau'r amodau gorau i'r Cyngor Cymuned.

- d) **Wales Air Ambulance** – (s137) It was resolved that the Council in accordance with its powers under Section 137 of the Local Government Act 1972, should incur the following expenditure which, in the opinion of Llandysul Community Council, is in the interest of the area or its inhabitants and will benefit them in a manner commensurate with the expenditure – Cllr Keith Evans proposed a donation of £300, this was seconded by Cllr Wyn Evans and carried.
- e) **Llangollen International Eisteddfod** – (s145) – Cllr Keith Evans proposed a donation of £50, this was seconded by Cllr Wyn Evans and carried.
- f) **Cardigan Womens Aid** – (s142) – Cllr Keith Evans proposed a donation of £50, this was seconded by Cllr Wyn Evans and carried
- g) **Shelter Cymru** – (s142) – Cllr Keith Evans proposed a donation of £50, this was seconded by Cllr Wyn Evans and carried.
- h) **Llandysul a Phontweli Ymlaen** – Confirmation was received that the Gardening Event had been a successful event and Llandysul traders had benefited from the event. Grant previously approved in the sum of £1,000 was passed for payment. We were also asked to consider financing the 2012 event as they will need to decide shortly whether the event is to be held next year and is to be placed on the Agenda for next meeting.
- 7 **Lloyds Bank Llandysul** – A discussion took place re closure of the Llandysul Branch and is to be placed on the Agenda for the next meeting for consideration. Cllr Peter Davies will make enquiries with the existing banks in Llandysul for the best terms for the Community Council.
- 8 **Review of Risk Assessment** – A copy had been circulated to all and was discussed and approved by the Council. The Risk Assessment had also been approved by the Internal Auditor, Mr R J Foulkes.
