 - i) **Papur Bro y Garthen** – Ni chafwyd adroddiad ynghylch eu cais i Geredigion am grant, a bydd y mater yn cael ei roi ar yr Agenda.
 - ii) **Cymdeithas Hanes Lleol Llandysul a'r Fro** – (a19) Cynigiodd Cyng Wyn Evans y dylid rhoi £250.00, eiliwyd hyn gan Gyng Douglas Davies ac fe'i dderbyniwyd.
 - 5 a) **Donations:-**
 - i) **Papur Bro y Garthen** – A report has not been received as to their grant application to Ceredigion and is to be placed on the Agenda.
 - ii) **Llandysul & District Local History Society** – (s19) Cllr Wyn Evans proposed £250.00, this was seconded by Cllr Douglas Davies and carried.

iii) **Ymddiriedolaeth Addoldai Cymru** – **Hen Gapel Llwynrhydowen** – Ei adfer at ddibenion diwylliannol ac addysgol, er budd y gymuned. Ystyriwyd ei werth hanesyddol i'r gymuned a chynigiodd Cyng Wyn Evans y dylid rhoi £10,000, eiliwyd hyn gan Gyng Breian Teifi ac fe'i dderbyniwyd. Bydd angen cael cadarnhad bod y gwaith yn mynd yn ei flaen cyn y bydd y rhodd yn cael ei roi.

b) Cafwyd **cydnabyddiaeth derbyn rhodd** gan **C Ff I Pont-siân** fel y trafodwyd dan “4” uchod.
6 **CCTV** – Cafwyd cydnabyddiaeth wrth Geredigion eu bod wedi cael ein llythyr, ond ni chafwyd unrhyw wybodaeth bellach. Roedd Pc Dafydd Jones wedi bwriadu mynychu'r cyfarfod, ond nid oedd ar gael. Yn ystod cwrs hyfforddiant U Ll C a gynhaliwyd yn ddiweddar, cyfeiriodd yr aelodau at y posibilrwydd o sicrhau CCTV ar gyfer Llandysul. Penderfynwyd estyn gwahoddiad i Pc Dafydd Jones a chynrychiolydd o Gyngor y Dref Castellnewydd Emlyn i fynychu ein cyfarfod nesaf er mwyn darparu'r wybodaeth berthnasol.

7 **Cau Banc Lloyds Llandysul** – Gwnaethpwyd penderfyniad unfrydol i agor cyfrif gyda H S B C Llandysul.

8 **Gohebiaeth**

a) Cafwyd y canlynol wrth **Geredigion:- Cynllun Datblygu Lleol Ceredigion:- Ymgynghoriad ynghylch Cyflwyniadau Dyrannu Safleoedd** ynghyd â gwybodaeth Ychwanegol, sydd ar gael ar y wefan hefyd. Penderfynwyd y byddai'r aelodau yn bwrw golwg arno, gan adrodd i Gyng Mrs Eileen Curry, a fydd yn ymateb ar ran y Cyngor Cymuned. Cawsom ein hysbysu o'r ffaith y bydd **Stryd Charles ar Gau** ar 27 Mehefin 2011 er mwyn gosod pibell BT.

b) Cafwyd **Comisiwn Ffiniau Llywodraeth Leol i Gymru:- Adolygiad o'r Trefniadau Etholiadol Sirol ar gyfer Sir Ceredigion**, ac fe'i nodwyd. Bydd ward Capel Dewi yn ymuno â Thref Llandysul. Bydd Pont-siân a Thre-groes yn ymuno â Throed-yr-aur.

iii) **Welsh Religious Buildings Trust** – **Hen Gapel Llwynrhydowen (Old Chapel)** - Restoration for cultural and educational purposes for the benefit of the community. Consideration was given to the historical value for the community and Cllr Wyn Evans proposed a donation of £10,000, this was seconded by Cllr Breian Teifi and carried. Confirmation will be needed that work is ongoing or completed before the donation is made.

b) **Acknowledgement of receipt of donation** was received from **Pontsian Y F C** discussed under “4” above.

6 **CCTV** – Acknowledgment of receipt of our letter was received from Ceredigion but no further information received. Pc Dafydd Jones had intended to attend the meeting but was not available. Members had raised the matter of CCTV for Llandysul at the O V W training course recently. It was decided to invite Pc Dafydd Jones and a representative from Newcastle Emlyn Town Council to attend our next meeting to provide the relevant information.

7 **Closure of Lloyds Bank Llandysul** – It was unanimously resolved to open an account with H S B C Llandysul.

8 **Correspondence**

It was decided that members would have a look and report to Cllr Mrs Eileen Curry who will then respond on behalf of the Community Council. We were notified of **Closure of Charles Street** on 27th June 2011 to lay BT duct.

b) **Local Government Boundary Commission for Wales:- Review of County Electoral Arrangements for The County of Ceredigion** was received and noted. Capel Dewi ward is to join Llandysul Town. Pontsian and Tregroes are to join Troed-yr-aur.

c) **Gwylwyr y Glannau Aberdaugleddau** – Ymgynghoriad ynghylch cynigion er mwyn moderneiddio gwasanaeth Gwylwyr y Glannau – Cafwyd ymateb gan Mark Williams AS. Yn ogystal, cafwyd posteri i'w harddangos gan Mark Williams, a oedd yn nodi y cynhelir Cymhorthfa ar 15 Gorffennaf yn Llandysul, ynghyd â manylion cyswllt cyffredinol.

d) **ULIC** – Cafwyd cydnabyddiaeth eu bod wedi cael y ffi Aelodaeth. Penderfynwyd enwebu Cyng Andrew Howell i fod yn gynrychiolydd y cyngor yn y cyfarfodydd chwarterol. Bydd Cyng Mrs Eileen Curry yn mynychu'r cyfarfodydd hefyd pan fo modd.

e) **Urdd y Benywod Pantydefaid** – Cafwyd gwahoddiad i agoriad swyddogol y ramp i'r anabl at ddefnydd y cyhoedd, a gynhelir ar 30 Gorffennaf 2011. Bydd Cyng Philip Marchant yn mynychu.

f) **LIGC** – Cafwyd gwahoddiad i ddigwyddiad “Cofleidio'r Llyfrgell” ar 15 Gorffennaf 2011 am 2.15pm, a bydd y Cadeirydd yn cadw hyn mewn cof.

g) **C A T h E M** – Mae ad-daliad TAW o £1,844.73 wedi cael ei dalu i mewn i'r banc.

h) **Cymdeithas Hanes Lleol Llandysul a'r Fro** – Arddangosfa Newydd – Cafodd y Cadeirydd a'r Clerc wahoddiad i'r agoriad, ond ni fu modd iddynt fynychu. Roedd Cyng Philip Marchant wedi mynychu. Adroddwyd bod yr arddangosfa yn wych.

i) **Cronfa Canser y Colon a'r Rhefr Canolbarth Cymru** – Cafwyd taflenni ac fe'u dosbarthwyd.

j) Hysbysodd **RAY Ceredigion** bod grant o £5,000 ar gael er mwyn datblygu Safleoedd Chwarae Cymunedol. Mae Pont-siân yn paratoi cais.

k) Cafwyd gohebiaeth a chylchgrawn **The Clerk**.

l) Cafwyd **Awdurdod Tân ac Achub Canolbarth a Gorrlewin Cymru** – Cynllun Gweithredu Blynnyddol Drafft 2012/2013.

m) **Apêl y Pabi Llandysul** – Cawsom ein hysbysu bod £1,767 wedi cael ei godi ar gyfer 2010. Llwyddodd **Bore Coffi Parti'r Pabi** i godi swm o £202.80 ar gyfer y Gronfa Les. Byddwn yn cael anfoneb am logi'r ystafell ar gyfer y bore.

c) **Milford Haven Coastguard** – **Consultation on proposals for modernising the Coastguard** – Response by Mark Williams MP was received. Posters for Display were also received from Mark Williams informing of Surgery on 15th July at Llandysul together with general contact posters.

d) **OVW** – Acknowledgement of receipt of Membership fee was received. It was decided to nominate Cllr Andrew Howell as representative at the quarterly meetings. Cllr Mrs Eileen Curry will also attend the meetings when possible.

e) **Pantydefaid Women's League** – Invitation was received to the official opening of the disabled ramp for use by the public on 30th July 2011. Cllr Philip Marchant will be attending.

f) **NLW** – Invitation was received to “Embracing the Library” on 15th July 2011 at 2.15pm, Chair will bear this in mind.

g) **H M R C** – Reimbursement of VAT has been paid into the bank in the sum of £1,844.73.

h) **Llandysul & District Local History Society** – New Exhibition – Invitation was received by Chair and Clerk to the opening, but had not been able to attend. Cllr Philip Marchant had attended. It was reported that the exhibition is excellent.

i) **The Mid Wales Colo-Rectal Cancer Fund** – Leaflets were received and distributed.

j) **RAY Ceredigion** informed that £5,000 grant is available to develop Community Play Areas. Pontsian are preparing an application.

k) **The Clerk** magazine and correspondence was received.

l) **Mid and West Wales Fire and Rescue Authority** – Draft Annual Action Plan 2012/2013 was received.

m) **Llandysul Poppy Appeal** – We were informed that £1,767 was raised for 2010. **Poppy Party Coffee Morning** which has now taken place raised the sum of £202.80 for the Benevolent Fund. We will be invoiced for the rent of the room for the morning.

- n) **Cyng Sir Peter Davies** – Cafwyd llythyr ynghylch y dybiaeth y bydd Ysgol Gynradd Sirol Capel Dewi yn cael ei rhoi ar y farchnad i'w gwerthu a chymeradwywyd hyn dan yr amgylchiadau. Bydd llythyr yn cael ei anfon at Geredigion yn gofyn a fyddai modd iddynt barhau i gynnal a chadw'r safle yn y cyfamser.
- o) **Plant Dewi** – Cafwyd gwahoddiad i fynychu gwasanaeth a gynhelir yn Eglwys Gadeiriol Tyddewi ar ddydd Sul 10 Gorffennaf er mwyn dathlu eu gwaith.

- p) **Pro-Fix** – Benches have been prepared ready for painting. First cut on footpaths has been carried out and Clerk has requested Ceredigion to inspect. Cllr Wyn Evans confirmed that the work had been carried out to a high standard.
- o) **Llinos Jones** – Translating - Invoice for May was received in the sum of £153.50 and passed for payment.

- 12 **Red Kiosks** – Display of information for the public was again discussed. Clerk to contact the Ceredigion Tourist Information Board enquiring re provision of a fixed stand for displaying information.
- 13 **Graffiti** – Graffiti on Bus Shelter near Beeches was discussed. Members will report further at the next meeting and bear in mind a suitable wall for graffiti.
