As the newly elected chair Cllr Peter Evans thanked the retiring chair and presided over the remainder of the meeting.

2 Declaration of Acceptance of Office including The Code of Conduct was signed by Cllrs Peter Evans and Eifion Rees.

3 Election of Vice Chair Cllr Peter Evans requested nominations for the position of Vice-Chair.

Cllr Gethin Jones, proposed Cllr Eifion Rees which was duly seconded by Cllr Keith Evans. There being no further nominations, the proposal was carried. Cllr Eifion Rees completed the Declarations of Acceptance of Office

4 Election of Planning Consultees Committee

6 Internal Auditor

It was resolved to ask Mr R J Foulkes to continue as Internal Auditor.

7 Internal Control/Internal Checker:- It was resolved that Cllr Gethin Jones continues in this role.

8 Finance Risk Assessment Appropriate steps to manage Internal Control/Risk Assessment and review of Insurance has been taken by the adoption of various policies, together with advice or guidance provided by Audit Wales and One Voice Wales.

Anogwyd yr aelodau i wneud cais am a cheisio goddefeb i bwyllgor Safonau a Moeseg Ceredigion os ydynt yn dymuno gwneud hynny.

Bydd y clerc yn atgoffa Rhodri Thomas o'r angen i gwblhau'r gwaith gofynnol wrth y safle bws yng Nghapel Dewi.

Hysbyswyd y Cyngor gan Gynghorydd Keith Evans o'r ffaith bod y Meinciau dan y Cynllun Trefi Taclus wedi cael eu gosod yn eu lle a bod yr hen feinciau wedi cael eu cludo i lawr i gaeau y Gymdeithas Chwaraeon er mwyn eu hailddefnyddio. Atgoffwyd y Cynghorwyr i ddod â gwybodaeth yn ôl erbyn y cyfarfod nesaf ynghylch ble yn eu pentrefi y maent yn dymuno gweld y meinciau newydd ychwanegol yn cael eu lleoli. Gofynnwyd iddynt hefyd a fyddai modd uwchgylchu'r hen feinciau er mwyn eu gosod yn rhywle arall.

9 To Receive Statement of Accounts Cllr Gethin Jones proposed that we accept the Statement of Accounts as a true record of the Council's transactions over the year, and agreed unanimously.

10 Declarations of Interest All members were reminded that it was their individual responsibility to declare their interest if discussing an item in which they had a declarable interest. Members were reminded that Cllr Keith Evans had sought and been given dispensation to speak and vote on issues appertaining to Llandysul Pont-Tyweli Ymlaen Cyf, Cymdeithas Chwaraeon Llandysul and Calon Tysul until September 2026. Members were encouraged to apply and seek dispensation to Ceredigion's Ethics and Standards committee if they so wished.

Declarations of interest were provided by Cllr Deiniol Evans who left the meeting during consideration of a joint request for a donation by Llandysul Carnival, Neuadd Tysul, and Llandysul Pont-Tyweli Ymlaen joint donation application. Cllrs Beth Davies and Peter Evans declared an interest and left the room during consideration of a letter from Calon Tysul.

11 Minutes of the monthly meeting held on 13th April 2026 were accepted as correct following amending Cllr Deiniol Davies to Cllr Deiniol Evans. in who was present and also adding that Beth Davies was present at the meeting., Also by changing that we had 2 vacant seats in the Llandysul Ward not as 1, that was noted in the vacant seat minute.

12 Matters Arising:-

Cllr Douglas Davies wished that a letter of thanks be sent to the County Council who had filled in most of the potholes in Capel Dewi area. They had also unblocked a drain that had been the cause of rainwater to run down the hill and into the Bus Shelter.

The clerk to remind Rhodri Thomas of the need to complete the required work at the bus stop in Capel Dewi.

Cllr Keith Evans informed the Council that the Benches under the Tidy Town Scheme had been put in location with the old benches taken to the Cymdeithas Chwaraeon fields for re-use. Councillors were reminded to bring back information by the next meeting of where in their wards they wished for additional new benches to be located. They were also asked if the old benches could be upcycled to be placed somewhere else.

Gofynnwyd am rodd o £300 gan Llandysul a Phontyweli Ymlaen/Neuadd Tysul a Charnifal Llandysul er mwyn trefnu pantomeim ym mis Ionawr 2027. Penderfynwyd rhoi'r swm y gofynnwyd amdano.

Nacro

Penderfynwyd talu £660 sef swm y rhent er mwyn cynnal cyfarfodydd misol Nacro yn Neuadd Tysul. Roedd y cynghorwyr yn ddiolchgar am y data a ddarparir o ran y niferoedd sy'n mynychu a math y gwasanaethau a gynigir. Mynegwyd gwerthfawrogiad i'r cynghorwyr sy'n mynychu ac sy'n rhedeg stondin y Cyngor Cymuned.

Calon Tysul

Ar ôl datgelu eu budd yn gynharach yn ystod y cyfarfod, gadawodd Cynghorwyr Beth Davies a Peter Evans yr ystafell tra bod y llythyr gan Galon Tysul yn cael ei ystyried. Arhosodd Cynghorydd Keith Evans yn y cyfarfod gan bod ganddo oddeffeb i siarad a phleidleisio.

Cafwyd llythyr gan Galon Tysul yn esbonio bod Cynghorydd Keith Evans, Ward De Llandysul, wedi sicrhau cefnogaeth ehangach Cynghorwyr Ceredigion, a sicrhau grant refeniw o £30,000 y flwyddyn at gyfer y Pwll, ac mae hwn yn cael ei ddarparu ar yr amod bod y cyllid gan Gyngor Cymuned Llandysul yn parhau, a gofynnwyd i'r Cyngor Cymuned ymrwymo i roi £6000 neu swm uwch am y 5 mlynedd nesaf.

Cafwyd trafodaeth yn dilyn hyn, ac amlygwyd y ffaith y byddai penderfyniad o'r fath yn ymrwymo'r weinyddiaeth newydd a fydd yn dod i rym ym mis Mai 2027.

Nodwyd hefyd y byddai angen i'r weinyddiaeth gyfredol ymrwymo gwariant ar gyfer blwyddyn gyntaf tymor y Cyngor newydd, sef 2027/28, oherwydd y byddai angen iddo osod y praecept ar gyfer y flwyddyn ddilynol, sef 2027/28 ym mis Ionawr/Chwefror 2027 er mwyn bodloni terfynau amser y Cyngor Sir.

Penderfynwyd y byddai angen i'r weithdrefn uchod gael ei dilyn gan y Cyngor presennol, a fyddai'n cynnwys ymrwymiad neu fel arall ar gyfer blwyddyn gyntaf y weinyddiaeth nesaf. Yna, byddai'n fater i'r Cyngor newydd benderfynu a fyddai'n parhau gyda'r arfer o gefnogi'r tri sefydliad gyda chyllid refeniw ar gyfer cyfnod y Cyngor newydd a fyddai'n weddill.

14 Gohebiaeth

Cllr Keith Evans explained that the order for the salt bins was proceeding with the County Council and they would be fulfilling it in the next couple of months.

The clerk to contact Royal Mail again with regards to moving the post box in Capel Dewi.

13 Donations

(Cllr Deiniol Evans left the meeting during consideration of the joint request from Llandysul Pont-Twelly Ymlaen /Tysul Hall and Carnival committee for organising a pantomime.

Pantomime

A request for a donation of £300 was requested from Llandysul & Pont-Twelly Ymlaen/Tysul Hall and Llandysul Carnival to organise and stage a pantomime in January 2027. It was decided to donate the requested amount.

Nacro

It was decided to pay £660 for rental of Tysul Hall to hold the monthly Nacro meetings. Councillors were grateful for the data provided in terms of attendances and the type of services offered. Appreciation was given to the councillors that attend and man the Community Council stand.

Calon Tysul

Cllrs Beth Davies and Peter Evans having declared their interest earlier in the meeting left the room during consideration of the letter from Calon Tysul. Cllr Keith Evans as he has dispensation to speak and vote remained in the meeting.

A letter was received from Calon Tysul explaining that Cllr Keith Evans, Llandysul South Ward having obtained the wider support of Ceredigion Councillors had secured a £30k p.a. revenue grant for the Pool, this being provided subject to the continuance of funding from Llandysul Community Council, and asking the Community Council to commit to donating £6000 or an increased sum for the next 5 years.

Discussion ensued and it was highlighted that such a decision would commit the new administration which comes to force in May 2027.

It was also pointed out that the current administration would need to commit expenditure for the first year of the new Council term 2027/28 as it would need to set the precept for the ensuing year 2027/28 in Jan /Feb 2027 to meet County Council deadlines.

It was decided that the above procedure would need to be followed by the current Council which would include a commitment or otherwise for the initial first year of the next administration. It would then be a matter for the new Council to determine whether it would continue the custom and practice to support the three organisations with revenue funding for the remaining period of the new Council.

Cllr Gethin Jones reported the presence of a pothole on the highway in Pontsian immediately adjacent to the former primary school in Pontsian.

Llandysul

It was reported that a member of the public had fallen on the pavement somewhere between Ffab siop up to Bon Appetito. It was decided that the clerk contact the County Council to report the incident and requesting an inspection of the footways and the highway condition within the town in Llandysul and to develop a programme to upgrade the condition of the assets.

Prenwyn

Councillor Eileen Curry informed the clerk that she had received numerous complaints from members of the public on the state of the road from Prenwyn to Tregroes and that it was dangerous in a number of places.
