Precept

Following a special meeting on the 15th of January to discuss the precept. Financial reports were presented for Councillors consideration, and it was agreed by all that an increase in Council Tax of 5% for the 2024/25 financial year which would yield £50,737.47.

Following a meeting with the County Council at Cardigan Secondary School which was attended by County Cllr Cllr Keith Evans and Council Chair, Beth Davies on 1st February. The County Council outlined their difficult financial settlement and the impact of high inflationary pressures on their ability to deliver certain services and were asking that consideration be given by the Community Councils to undertake responsibility of some of these functions, e.g. public toilets and to maintain greenspaces. The County Council would forward in due course minutes of the meeting which would highlight issues raised at the meeting. It was decided that the clerk contact Ceredigion requesting information on the cost to run and maintain the public toilets at Llandysul. Ceredigion had also given Community Councils an opportunity to change their precept by extending the closing date to 14/02/2024. It was decided to remain with the 5% increase for the 2024/25 financial year.
